  - iii) The number of children referred to GIDS that attended state schools, again, broken down by age
- 2. If the information is available, please disclose how many of the children, broken down into age groups, progressed onto blockers and then cross-sex hormones.
- 3. If possible, please can you disclose which local authorities the schools are located in and how many from each authority.
- 4. If possible, please disclose the positions of the adults that made the referrals, eg. how many were classroom teachers/ SENCOs/ Heads etc.

## Response sent

1. The total number of children (all children aged 18 and under) referred by schools to your service, from when referrals first started being made by schools until the service closed.

If possible, please can you also provide the following:

- iv) The ages of the children referred to the GIDS service each year, broken down into age intervals of 1 year.
- v) The number of children referred to GIDS that attended private, fee-paying schools, and if possible, broken down by the ages of the children
- vi) The number of children referred to GIDS that attended state schools, again, broken down by age

Please note that the service has not yet closed. The data below reflects the following points.

- Since August 2021, referrals from groups other than CAMHS/pediatric services (for example referrals from Schools, GPs) have been sent directly to a Referral Hub, run by Arden and Gem CSU (AGEM).
- Since October 2022, all referrals received after 10 October 2022 have been forwarded, unprocessed, to the AGEM Referral Hub.

- We do not hold data on whether GIDS patients attended state or private fee paying schools.

2. If the information is available, please disclose how many of the children, broken down into age groups, progressed onto blockers and then cross-sex hormones.

Whilst we confirm that the Trust holds some information falling within this scope, our computerised patient records system hold this data in the freetext sections of patient files, from which we cannot run automated search and collate functions, and so we cannot run a report electronically.

We have estimated that it would require resources beyond those provisioned under section 12 of the Freedom of Information Act 2000 (FOIA), to manually trawl through all 160 files to identify, extract and collate such data into a report.

Spending a notional 20 minutes per patient file to manually search and extract this data would take circa 53 hours of officer time. Section 12 of the Freedom Of Information Act 2000 (FOIA) allows a public authority to refuse questions where it estimates that the work required would exceed the appropriate limit. The appropriate limit for the NHS is currently set at £450 which equates to 18 hours of staff work, calculated at a generic rate of £25 per hour. Accordingly, the Trust is not obliged to respond to this question and so we will not be processing it further.

Should you wish to narrow the scope of this question, eg for the last two financial years, 2021/2022 and 2022/23 then the Trust would treat any reformulated request we receive as a fresh FOI request and we may be able to help you further.

- 3. If possible, please can you disclose which local authorities the schools are located in and how many from each authority. We do not hold this data by school, nor by local authority, however we can identify GIDS referrals by county, which may be of assistance to you, as nearly all of our referrals are for school age children, from a whole variety of sources. - If possible, please disclose the positions of the adults that made the referrals, eg. how many were classroom teachers/ SENCOs/ Heads etc. The following data was extracted from non-mandatory free text fields, which are sometimes left blank, or do not always contain the occupation of the referrer.
