 - i. Zero cases. Such patients are not being referred to this Trust by primary care services.
 - ii. The Tavistock and Portman NHS Foundation Trust is a specialist mental health Trust which provides outpatient psychotherapy services only. The Trust has no A&E or in-patient departments and does not provide statutory services.

 - i. The Trust uses a number of risk assessment tools to detect and assess risks: and modern day slavery and human trafficking are included within the assessment protocols.

- ii. The Trust provides safeguarding training mindful of national, regional and local expectations
 - iii. The Trust uses the following interventions to design training courses which ensure clinicians are informed about modern day slavery and human trafficking including biopsychosocial antecedents.
 - a. the Inter-Collegiate Document (ID) (children)
 - b. the consultation (ID) for adults

During the period 1st January 2016 - 31st December 2017) this Trust will have provided 23 safeguarding training events which include awareness level training regarding modern day slavery and human trafficking.
4. Please advise what specific projects your organisation is taking related to tackling modern slavery and human trafficking? [This might include staff awareness days, specific training, nurse-led projects, conferences etc]
- i. The Trust, as a partnership agency of the Camden Safeguarding Children Board, has supported the awareness agenda of modern day slavery and human trafficking, and specifically in regards to children identified as missing children.
 - ii. significantly increases vulnerability. The Trust has audited the status of being a missing child or young person in tandem with the Camden Safeguarding Children Board work plan.
 - iii. The Rotherham Inquiry Report was also highly influential within the Camden children's workforce: understanding that children and young people can be trafficked around the country and not just beyond UK borders.
