PLEASE NOTE: Please note that the undertaking of physical intervention training/ physical restraint is not practiced Trust-wide, and is only in place at Gloucester House, the Trust Day Unit for pupils aged 6-14 years. All the following responses are given with reference to Gloucester House only, and do not apply to the rest of the Trust's services.

 What system of physical intervention training / physical restraint system is taught to staff in your Trust e.g. in-house own system, MAPA/Maybo/GSA/WLMHT/SCIP/Respect/Peace etc. At Gloucester House Day Unit for pupils aged 6-14 only— Staff are taught Team Teach, a basic 12 hour course

Does the system include or teach staff the use of prone restraint?

- i. The basic 12 hour course, described above does not include prone restraints.
- ii. The on-site trainer is trained to advanced level. If a specific child has a risk level that necessitates the use of higher level restraint (prone front ground recovery) we train an appropriate number of staff to the advanced level.
- iii. These staff are also required to hold first aid certificates. We are currently not using prone restrain with any of our pupils and we involve the network and develop a specific plan if we think we are going to need to use prone restraint with any of our pupils.
- 2. How is this training system accredited/validated (internal/external agency)?

  At Gloucester House Day Unit for pupils aged 6-14 only, the Deputy Head Teacher is an accredited advanced Team Teach instructor with external accreditation. Team Teach is accredited by The Institute of Conflict Management (ICM)
- 3. What system do you use to collect data on the use of restraint, prone restraint, supine restraint and seclusion e.g. Datix / Rio or other?
  - At Gloucester House Day Unit for pupils aged 6-14 only:
  - i. We record all physical intervention through our internal system of day sheets (paper record) and using the trust's new online incident reporting system (bespoke computer based system developed for the trust).
  - ii. Any restraints are logged in a bound numbered book.
  - iii. Any injuries are recorded in accident book and through online incident reporting system.
  - iv. The bound log book requires staff to record injuries during restraint to pupil or staff.
  - v. If we have an individual identified as needing higher level of restraint, and staff trained to carry out prone restraint (front ground recovery) we also report to Team Teach about how often it is being used via a paper form, submitted half termly

At Gloucester House Day Unit for pupils aged 6-14, there were no injuries to pupils during prone restraint; injuries to children were two wobbly teeth (both 'baby' teeth) from accidental knocks and one child banging head. None of the injuries were severe and needed only basic first aid treatment.
