Response Sent

I can confirm that the Trust holds information that falls within the description specified in your request, but we have estimated that it will require more resources than that provisioned under the Freedom of Information Act 2000 (FOIA 2000) to consider your request. Section 12 of FOIA 2000 provides for refusal of requests for information where the cost of dealing with them would exceed the appropriate limit of 18 hours/£450. We have estimated that to fully respond to your request would require resources in excess of this; at around 28 hours of work. I hope you will understand that the Trust is therefore not obliged to respond to this enquiry, so we will not be processing it further.

The Trust holds, but does not electronically categorise, this data in collatable fields which would otherwise have enabled us to run a dedicated electronic report for you. The questions you have raised would require manual interventions in obtaining various financial statements across multiple cost centres, analysing the data in to a format to be able to respond, securing written information and summarising several different time report, obtaining procurement and contract details, analysing various members' of staff's time. It would require around 28 hours of staff time to undertake and complete this piece of work.

Should you wish to narrow the scope of your request then the Trust would treat any reformulated request we receive as a fresh FOI request and we may be able to help you.
