For your reference, Assigned Gender at Birth refers to patients natal gender, and this data is provided below.

Whilst I can confirm that we hold some data on binary patients, we are unable to report this statistically, because it is not routinely recorded. To extract and collate data on binary patients into a report would require a manual examination of the freetext sections of thousands of patients files, and manual identification, extraction and collation of relevant data. The resources required to undertake this would greatly exceed the 18 hour provisions of section 12 of the FOI Act 2000, and therefore we will not be responding that that part of your enquiry.
