- 5. For the past 10 years the number of days between first referral, prescription of hormone blockers and prescription of cross-sex hormones
- 6. For the past 10 years the number of children prescribed with hormone blockers who do not proceed to further treatment
- 7. For the past 10 years the number of children (under 18) offered gamete storage and their respective age at time
