I would like to request the following information for the calendar years of 2017, 2018 and 2019, for each of your clinics (The Tavistock and Portman NHS Foundation Trust Gender Identity Clinic for Adults, and Gender Identity Development Service for children and young people) as applicable.

- 1. Per year, per Clinic, how many patients sought hormone replacement therapy per year.
- 2. Per year, per Clinic, the average wait time between their referral to the Gender Identity Clinic (by a GP or counsellor, for example) and their first appointment at the Clinic.
- 3. Per year, per Clinic, the longest and shortest wait times between the patient's referral to the Clinic and their first appointment at the Clinic.
- 4. Per year, per Clinic, the average duration between the first appointment at the Clinic and the start of HRT.

Per year, per Clinic, how many patients sought hormone replacement therapy per year.
