Table 1 presents the number of referrals to endocrinology for puberty blockers by year and month (01/12/2020 - 27/01/2022). Data reveals no referrals to endocrinology for puberty blockers in the year 2020 from 01/12/2020. Data shows referrals to endocrinology for puberty blockers in 2021 (n = 26) and 2022 to date (n = 6). Data reveals no referrals between the months of December 2020 to May 2021 for puberty blockers. Data shows referrals for puberty blockers in June 2021 (n = 7), July 2021 (n = 3), August 2021 (n = 2), September 2021 (n = 2), October 2021 (n = 1), November 2021 (n = 6), December 2021 (n = 5) and January 2022 (n = 6).

- 2. Please confirm the ages of the children so referred at paragraph 1 above Patients were aged between 12 and 17 at referral to endocrinology.
  - 3. Please confirm the date of inception of the NHS England Multi Professional Review Group and the number of children and ages of the children who have been seen by the NHS England Multi Professional Review Group on a month by month basis since inception of the Group in 2021;
    - The date of the first meeting where submissions were considered was 1 September 2021
    - Eight patients had been seen by the Multi Professional Review Group (MPRG) by end September 2021, five aged 13 and three aged 14-15. We cannot provide a more detailed breakdown due to low numbers and the potential risks of identification. The exemption under Section 40(2) of the FOIA, *Personal information* has been engaged in this respect as disclosure could lead to a breach of the UKGDPR/DPA 2018.
  - 4. Please confirm how many children seen by the NHS England Multi Professional Review Group have:
    - Been referred on for treatment/assessment for puberty blockers to either of the endocrinologist hospitals or elsewhere **Seven (as at end September 2021)**
    - Been refused a referral on for treatment/assessment for puberty blockers None
    - Seen an endocrinologist and commenced assessment for puberty blockers We do not hold this data.
    - Received a prescription for puberty blockers We do not hold this data.
