Hi Caroline,

Just to let you know - as a courtesy - that I plan to post a lengthy thread tomorrow on suicides in GIDS at the Tavistock. It draws on some data not previously discussed in the public domain. I don't propose to name you - and the thread isn't especially critical of the Tavistock - but I do mention the presentation to Tavistock staff given by the Interim Chief Medical Officer and Named Doctor for Safeguarding Children (which you held at the relevant time).

We will of course go to the Tavi's press office - which hasn't been especially cooperative so far. But I'd be happy to have a confidential and off the record conversation with you about it if you like. And please forgive me if this email is unwelcome - I promise I won't make a habit of it.
