I did this summary for Michael and Jane last week, hope it is what you need for the FOI request?

Summary

The Good Law Project is a not-for-profit organisation that uses the law to campaign. They are primarily funded by members of the public. They publish stories on their website and work with other media to publish together.

During the last 2 weeks they emailed the media inbox twice (see emails attached) with a series of questions and claims that we refute. When they didn't get what they needed to formulate an article, they emailed Caroline McKenna giving her a heads up (see email attached) that their Director Jo Maugham was about to launch a lengthy thread on X which included documents attributed to her between 2022 – early 2024. Sally Hodges is also named on documents in the thread. [REDACTED] and I have been supporting [REDACTED] and [REDACTED] and working with [REDACTED] and [REDACTED] to ensure none of the claims or documents in the thread are new pieces of information beyond what we are already aware of.

We are also working with [REDACTED] at NHSE (see email attached) to prepare for any further media interest and yesterday we received an email from New York Sun and New York Times referencing the Good Law Project thread (see email attached) asking for the same information as the Good Law Project's original request.

I have now seen further evidence that, since the Bell decision in the High Court (1 December 2020), there has been a huge increase in deaths of young trans people on the NHS waiting list - and that NHS management has sought to suppress that evidence.
